Dear Gentlemen:

This letter is to inform you that, effective September 1, 2020, Circus Circus, LLC is permanently laying off employees who work at 2880 Las Vegas Blvd. South, Las Vegas, NV 89109.

There are 252 employees being permanently terminated at this employment site, all of whom will be affected on September 1, 2020. The Company commenced furloughs, permanent terminations, and reductions in hours of 2,074 employees on March 17, 2020, and these job actions have continued and will continue through September 1, 2020.

Whether or not this action triggers the requirements of the Worker Adjustment and Retraining Notification Act, we thought it appropriate to give you this notice. We are taking these employment actions because of COVID-19-related natural disaster, national emergency, and business circumstances that were not reasonably foreseeable. We would like to have given more notice of this action, but were unable to do so because of how quickly and unexpectedly our operations were affected by the COVID-19 pandemic, the World Health Organization's pandemic declaration on March 11th, the President's declaration of a national emergency on March 13th, and other related governmental announcements and actions.


